I, the undersigned, from here on referred to as "renter," understand that I have entered into a rental agreement with Ozzie's Music Inc. under the following terms:

- The renter agrees to pay \$_____ which includes the first ____ month(s) rental fees and a one time instrument set up fee of \$15.00. Monthly payments of \$_____ are due on the _____ day of each month beginning on _____ and continuing until the rental instrument is returned to Ozzie's Music Inc. (Initials) _____
- A packet of pre-dated coupons will be mailed to the renter to be returned with payment. No other monthly reminder will be sent. **Your Credit Card will not be automatically charged.** Instruments must be returned on or before the next payment due date to avoid additional rental fees. **No partial or unused month's rent will be refunded at any time.**
- Rental payments are considered past due ten (10) days after the due date. If three (3) consecutive rental payment are missed, the renter's account is placed in default until the rental instrument is returned and backrent is paid in full. If instrument is not returned the renter must pay the the replacement value for the instrument. Further, the renter agrees to pay all reasonable attorney's fees, collection costs, court fees, and other costs incurred by Ozzie's Music Inc. in relation to this contract.
- The renter understands that this contract is a rental only, and not a sales contract. The instrument described above is solely and exclusively the property of Ozzie's Music Inc. and at no time does the renter have a secured interest or any rights of ownership in said instrument.
- The above instrument is covered against accidental damage, normal usage, regular maintenance, and theft under the following conditions:
 - The renter's account must not be past due as defined in item 3 above.
 - In the case of theft, a valid police report must be filed within three (3) days of the theft and a copy of said report must be provided to Ozzie's Music as soon as possible.
 - At no time are consumable items such as reeds, lubricants, or strings covered under this agreement.
 - At no time is the instrument covered against intentional damage or damage resulting from misuse or neglect.
 - At no time is any person, repair facility, or entity other than Ozzie's Music Inc. authorized to service or repair the rental instrument beyond daily care. The renter is responsible for any unauthorized servicing, repair, or any resulting damage.
- If the above instrument is lost, stolen, or damaged beyond repair and the conditions set forth in item 5 above are not met, the renter agrees to pay Ozzie's Music Inc. the full amount listed as the "replacement value" in the description above.
- The renter agrees to notify Ozzie's Music Inc. of any changes of address or phone number during the course of the rental period.
